

## **Additional Terms for Services with Generative AI Skills**

### **1. APPLICABILITY**

- 1.1. These Additional Terms for Services with Generative AI Skills ("GenAI Terms"), as they may be amended from time to time in accordance with the Agreement, apply when you use or access Services with generative AI skills ("GenAI Skills"). "You", "your", and "Customer" mean the client, customer, or subscriber identified in the Ordering Document and "we", "our", and "Thomson Reuters" mean the Thomson Reuters entity identified in the Ordering Document and, where applicable, its Affiliates, and our and their employees, contractors, and third-party providers.
- 1.2. These GenAI Terms supplement the Agreement and govern specific aspects of the Services, overriding any similar terms contained within the Thomson Reuters General Terms and Conditions (or other applicable governing terms) with respect to the Services. These GenAI Terms may be further supplemented by product specific terms, as applicable. If there is a conflict between these GenAI Terms and any other document forming the Agreement, the order of precedence is as follows: Ordering Document, product specific terms, these GenAI Terms, annexes, schedules, and the Thomson Reuters General Terms and Conditions (or other applicable governing terms).
- 1.3. Unless otherwise defined herein, any capitalized terms shall have the meanings given to them in the Order Form or the Thomson Reuters General Terms and Conditions (or other applicable governing terms), as applicable.

### **2. DEFINITIONS**

- 2.1. **"User Content"** means user content or documents (i) uploaded by a user to the Services or (ii) accessed by a user via an integration with the Services, each for the purpose of using the GenAI Skills.
- 2.2. **"User Prompt(s)"** means an input provided by a user to the Services in the form of a query, statement, or instruction, intended to guide the Services in generating an Output or completing a task using the GenAI Skills.
- 2.3. **"De-identified User Prompt"** means where Thomson Reuters has de-identified metadata associated with a User Prompt so a user is no longer personally identified.
- 2.4. **"Output"** means an output generated and returned by the Services to a user in response to a User Prompt.
- 2.5. **"Property"** has the meaning set forth in the current Thomson Reuters General Terms and Conditions. To the extent that your Agreement defines the same or similar term, such term shall be deemed replaced and superseded by the definitions in the current Thomson Reuters General Terms and Conditions.

### **3. INPUTS**

- 3.1 You may provide a User Prompt and User Content to the Services and receive a resulting Output from GenAI Skills. As between the parties, you own, or have the relevant third-party licenses, legal grounds, consents or permissions to, User Prompts and User Content.
- 3.2 With respect to User Prompts only, we may create and use De-identified User Prompts to improve the performance, functionality, and overall user experience of the Services. We will take reasonable steps to ensure that all such De-identified User Prompts are not re-identified by us or any third party.
- 3.3 We will not, and will not permit our third-party providers to, use User Prompts, De-identified User Prompts, or User Content to develop, train, or improve a generative AI large language model, i.e., to enhance the language understanding or generative capability of such model.
- 3.4 When using or accessing the Services, you must not provide Thomson Reuters with any User Prompts or User Content, including any personal data (as defined by applicable law) in User Prompts or User Content, which violate, misappropriate, or infringe the rights of any third party, applicable law, the Agreement, or these GenAI Terms.

### **4. OUTPUTS**

- 4.1 To the extent permitted by applicable law and to the extent any ownership rights exist in Output, as between you and us, you own Output generated from your User Content, subject to our third-party licensors' rights and any rights we have in our Property. Otherwise, as between you and Thomson Reuters, we retain ownership of Output.
- 4.2 Outputs (or parts thereof) generated without User Content shall be owned by us, and you are granted a non-exclusive, worldwide, royalty free license to use the Output, subject to the use restrictions set forth in the Thomson Reuters General Terms and Conditions (or other applicable governing terms) and/or these GenAI Terms.
- 4.3 You acknowledge that you may receive Output that is similar or identical to Output generated by the Services for other users.
- 4.4 You may not use our Property or our third-party providers' property to train or develop any artificial intelligence or machine learning algorithms or software, or create any derivative works, compilations or collective works or in any manner or for any purpose that infringes, misappropriates, or otherwise violates any intellectual property right or other right of Thomson Reuters or any person, or that violates any applicable law.
